1. Registered with Govt./Semi Govt. Departments/Autonomous Bodies in appropriate class.
2. Minimum Annual Turn over from Construction works during last 3 consecutive years shall not be less than **1.75 lakhs**.
3. Should have **completed** satisfactorily building work or brick boundary wall work of (i) *one work* of value not less than **4.23 Lakh** *against single work order* **OR** (ii) two works of value not less than **3.64 Lakh** each *against two separate work orders* **OR** (iii) three works of value not less than **2.11 Lakh** each *against three separate work orders* during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **work order and completion certificate**.
4. The tenderer shall sign and stamp each page of this tender document as token of having read, understood and comply with tender, the terms and conditions contained herein. This tender document is required to be uploaded on the website <https://eprocure.gov.in> **along with scanned copies PAN, GST and qualifying documents, as per the qualifying criteria stated above in serial no.1,2 and 3**. Incomplete bid/documents shall be rejected without giving any reason.
5. Bidders will be required upload the scanned copies of the Demand Draft against tender fee (non-refundable) and Earnest Money drawn in favour of the Registrar, Tezpur University payable at Tezpur.
