Should have **completed** satisfactorily Civil works of (i) *one work* of value not less than **0.97 Lakh against single work order OR** (ii) two works of value not less than **0.61 Lakh** each against *two separate work orders OR* (iii) three works of value not less than **0.49 Lakh** each against *three separate work orders* during last seven years in Govt./ Semi Govt. Department/Autonomous Body supported by **work order and completion certificate**.
4. The tenderer shall sign and stamp each page of this tender document as a token of having read, understood and comply with tender, the terms and conditions contained herein.
